(AMONG THE MOST VULNERABLE IN NEPAL). IN A NURTURING ENVIRONMENT, THESE CHILD TRAUMA SURVIVORS ARE EMPOWERED TO EXCEL AND FULFILL THEIR DREAMS. J HOUSE (FOR BOYS) AND K HOUSE (FOR GIRLS) EACH HELD ONLY UP TO 30 CHILDREN. SINCE THEIR INCEPTION, THESE HOMES WERE LEASED, RESULTING IN PERIODIC DISRUPTION DUE TO LEASE EXPIRATIONS AND RELOCATIONS.
