MANY YOUNG PEOPLE IN NEPAL SEE SUCCESSFUL CAREER PROSPECTS IN SKILLED TRADES AND ENTREPRENEURSHIP. THOUGH THE DEMAND IS HIGH FOR THESE SKILLS, NEPALESE COMPANIES OFTEN STRUGGLE TO FIND LOCAL YOUNG PEOPLE POSSESSING THE PROPER SKILLS-SO MANY OF THESE POSITIONS ARE FILLED BY WORKERS FROM INDIA AND OTHER COUNTRIES. MEANWHILE, YOUNG NEPALESE MEN AND WOMEN (CONTINUED ON SCHEDULE O)
